



## Coach Waiver, Release of Liability and Indemnification Agreement

I hereby release, hold harmless, discharge and agree not to sue or pursue any remedy in court or otherwise against JMK Developers, Peace of Mind Early Education Center, or anyone associated with any of the aforementioned organizations, including it's owners, administrators, agents, servants, associations, employees, for any claim, damages, costs or cause of action which my child or any child I am supervising may have now or in the future as a result of injuries or damages sustained or incurred by me or from whatever cause.
3. **I hereby voluntarily accept responsibility for any damages inflicted on the property or contents by our team and will agree to reimburse Peace of Mind Early Education Center for any costs to repair any damages incurred as a result of any and all parties associated with our teams use of the premises as related to this rental.**
